



PRE-LOVED UNIFORM CONTRACT

Due to the huge increase of pre-loved uniforms being handed in to sell, it is now necessary to implement guidelines for their acceptance. The following conditions apply:

1. Pricing and Commission Fee

All accepted items are sold on behalf of yourself at set prices & will incur a standard commission fee of 50%.

2. Payment

Payments will be made following sale of the garment/s by way of either credit to your school account or direct credit to your bank account. No cash payments will be made.

3. Rejected Items

Any items that are not accepted for sale must be removed from the shop immediately. Items that are left at the shop unchecked and deemed unsuitable for re-sale will be held for collection for 7 days. Items not collected will be disposed of.

- Only current, unaltered regulation school uniform items in excellent condition will be accepted. Garments subjected to fair wear and tear will not be accepted.
- All items must be CLEAN.
- NO swimming costumes, shoes, tights, socks and hats will be accepted.
- Garments will be accepted at Management discretion only.

If you are unsure if your garments are in a saleable condition, the shop staff will be happy to advise you.

NO CLOTHING WILL BE ACCEPTED UNLESS HANDED IN WITH A SIGNED TERMS AND CONDITIONS FORM. ACCEPTED GARMENTS WILL BE HELD FOR ONE TERM AFTER WHICH YOU MAY UPLIFT OR DONATE TO THE SCHOOL.
